CAROLINA BAYS RESORT NARRATIVE

The proposed development within the tract, HC TMS # 34800000012, consists of five (5) single-family residential estate lots. According to Grand Strand Water and Sewer Authority (GSW&SA), the nearest potable water and sanitary sewer infrastructure is located off of Bourne Trail. The distance is in excess of 2,000 feet.

An estimate of probable cost to provide water and sewer service to these five (5) lots is attached. Based on this cost, it would be our recommendation to seek work with GSW&SA to install a municipal system to serve these lots. If septic tank approval in this area is not likely, GSW&SA's extension policy may bring some relief in total cost.
